A Sole Proprietor, Partnership or Corporation whose owner (Sole Proprietor), Partner (Partnership), or stockholder (Corporation) is the only enrollee in the group program and does not have any full-time employees.

- One Month's Premium made payable to Blue Care Network on a company check
- Copy of New Business Proposal/Quote
- Submitted with proper lead time - 30 days
